To note the following actions to be carried out, in the light of Council's possession of 4 VAS devices and poles. Information generated from the VAS devices to be submitted to the Police and PCC to demonstrate the requirement for speed restrictions. It was understood that speed limits should be set at the 80th percentile of vehicle speeds monitored. To contact the school to provide designs for roadside speed warnings, and consideration would be given to provide additional VAS devices at the school. The area Highways manager to be contacted to advise on and provide speed signage. Risk Assessments and appropriate insurance to be

provided to protect those undertaking speed checks.

In respect of highways flooding at Allbright Lane, to seek a site

survey by GCC Highways to identify and mitigate the risks.

Consultation with GCC Councillor G Moseley to identify funding available for traffic management funding.
